Greetings,

I am pleased to share the Nebraska Action Coalition's (NAC) progress with all of you: our past, current, and future donors. In addition to the highlights below, please take a moment to review the information enclosed.

## **Accomplishments**

- Awarded a Future of Nursing State Implementation Program grant for \$150,000/2 years from the Robert Wood Johnson Foundation (RWJF) in January 2013.
- Added eight accomplished Strategic Advisory Committee members since 2012.
- Completed a pilot of statewide competency-based nursing education outcomes in spring 2014 and gap analysis. Second phase to begin in fall 2014
- Established collaboration with Nebraska Nurse Practitioners (NNP) to move toward *full NP practice authority* through statewide education.
- Built momentum toward a 10-percent increase of diverse (race, rural, men) nurses on boards based on leadership survey answered by over 1,000 nurses.
- One of eight states featured in a RWJF case study sharing best practices across the nation's 50 Action Coalitions.
- Engaged new partners by hosting regional stakeholders' breakfasts and nursing/interprofessional conferences.

## **Funding**

Our operating budget will be \$700,000 through 2020. Since becoming an Action Coalition in September 2011, the NAC has raised \$258,000 to support our work in health care transformation (not including in-kind donations estimated over \$100,000). We need to raise another \$100,000 annually to continue our work.
